## **Conduct issues of the Committee for Property**

Main principles of regulation of economic activity and the forecasting of their development;

Reforming property relations;

Reorganization of the power of attorney system of the government for control over state and municipal property;

Elaboration and development of state and market mechanisms to regulate the activities of economic entities in various sectors of the economy;

Improvement and efficiency of government regulation of business activities;

Agrarian constitution, regulation of land relations and the expression of the land-ownership properties;

Management and disposition of state and municipal property, inclusive of the shares, belonging to federal property;

Licensing of individual activities;

Elaboration of the principles of self-regulation of the economic and professional activity in the various sectors;

Insolvency (bankruptcy), financial reorganization and restructuring of loan obligations of citizens and legal persons;

Reorganization and liquidation of commercial organizations;

Privatization of state and municipal property

Confiscation of the property (nationalized) for state and local needs;

Requisition and confiscation of property;

Restitution of property;

Regulating the legal status and activities of legal entities of all organizational and legal forms, including corporations, ltd, cooperatives, production, state and local uniform companies (including state enterprises), non-profit organizations (in terms of economic activity );

Regulation of the legal provision and operation of public corporations, companies (holding companies), the financial and industrial groups and other integrated economic structures;

The lease of the property;

Confidential management of shares (shares) and other property;

Mortgage;

Affiliated person, business regulation with potential use of insider information;

Activity regulation and restructuring of natural monopolies (including fuel complex, transport, telecommunications);

Reorganization of the ownership structure of institutional investors, professional participants of the securities market, issue and circulation of corporate securities, protection of investor rights and their legal interests

Legal regulation of some types of business activities: real estate activities, exchange activities, assessment activities and activities related to sales of excise goods;

Management and disposal of property and actives that are located outside the Russian Federation;

Formation of the federal budget as revenue from the use of national property, as well as revenue from the privatization of federal assets.
